## **Count I**

That on or about April 7, 2008 through April 25, 2008, at or near Anchorage in the Third Judicial District, State of Alaska, DENNIS SIBAYAN BATAC, knowingly submitted or authorized the submission of a claim to a medical assistance

agency for property, services, or a benefit with reckless disregard that the claimant is not entitled to the property, services, or benefit.

All of which is a class C felony offense being contrary to and in violation of AS 47.05.210(a)(1) and against the peace and dignity of the State of Alaska.

#### **Count II**

That on or about April 7, 2008 through April 25, 2008, at or near Anchorage in the Third Judicial District, State of Alaska, DENNIS SIBAYAN BATAC committed the crime of theft and the value of the property or services was \$500 or more.

All of which is a class C felony offense being contrary to and in violation of AS 11.46.130(a)(1) and against the peace and dignity of the State of Alaska.

#### **Count III**

That on or about April 7, 2008 through April 25, 2008, at or near Anchorage in the Third Judicial District, State of Alaska, DENNIS SIBAYAN BATAC with intent to defraud, made or caused a false entry in the business records of an enterprise.

All of which is a class C felony offense being contrary to and in violation of AS 11.46.630(a)(1) and against the peace and dignity of the State of Alaska.
