

Pinerlucimalriarukuvet makunek piyunarkucingkertuten:

✓ **Aulukumallerkan kigcikklluten cali al-lakaukevkenak caliakekatni ilallkumallren.**

✓ **Temevkun akngirimakuvet ermian yungcaristemun yuvrirnakciguten.**

✓ **Piyunagkucingkertuten murillkumal-lergavnek qanercetarumalriim tungineq cukcistem pikiugani anumaqercuutiinek cali/wall maligtaquarkanek ankan.**

✓ **Nakukumaguvet wall alingcirarumaguvet una caliaq pitekluku piyunagkucingkertuten muril-lqumallerkavneq.** Kia nakukikaten wall alingcirar-qaten, qayaraukiqigi itercistet wall District Attorney-t Office-ara. Ukut waten ikaiyugyugngacikatren:

1. Tauna yuk nallunaigluku wall tuam alerkuatiin qanrutniara qenucetaresgevenaq;
2. Qanginaugluku cali pinargekan, tegu-luku cali itercimallerka ayagnigluku;
3. Cukcista aplluku tauna yuk atam iterteskel-luku, tauna yuk anevkallrukakni;
4. Maniiluteng apertulluki uita-viit piavngalriit nunavni.

✓ **Piyunagkucingkertuten utakaman-gitllerkavnek caliam egmiutellerkanek tegumararcelluku qanercitagumalria.**

✓ **Piyunagkucingkertuten augaumangitllerkavnek caliapenek pitekluku calian unicumal-allren qanercetavgigmun ayaugamallerpeni piskucia atugluqu itercingnaqkestem calistem.**

✓ **Piyunagqucin atugluqu apkaurluqi cali niicagtugluqi qanercetavgigmi ni-itellrutekllugu qanercetagumalria.**

✓ **Piyunagqucin atugluqu uitavivet nanlucia piavtevkagpeknaqu.**

✓ **Niicimagqauluten piyunagqucingkertuten itertaq anumallerqiukatni, ellpet apellciquvet.**

✓ **Piyunagqucin atugluqu qanrucimagqauruten kaqu qanercetarumalria qanercetarvigmi qanginaullerka cali itercimallerquikatu; cali nallunairumallerkavneq cimiqatru qanercetallerka wall apellciqata yakvakanigyu-gluqu caliaq mana qanginaullerka.**

✓ **Piyunagqucingkertuten qalarucungaluq calista waken DA-m calivianek (pinerlugci-malriit piteqlluqi piavngauk una ikaiyugta calituli aciani lisngapialriit calituli alerkutneq apgumaluni victim witness paralegalaq).**

✓ **Piyunagqucin kanrutcimarkaугuten, qanercetarumalria natakimarartelluqu, allaneq nataqumallrukan navgiullrulini-luku alerkutneq.**

✓ **Qalagucuquvki wall qalagucuminaki nallunairutesten, cucuqllikan ellpet, piyunagqucingertuten cucuqllillren qalarutnaluki qanercetarumalriim ikaiyugtai.** Natakumalleq alerkutmek navrilleg ikaiyugtengkertuq alerkutneq calitulimeq. Nallunairumacikuten aipagni ukugek ikaiyugteneq wall kanginaugtenun. Makut calistet qanrarquarut kinqut pitekluku calicimeg-neq. Apellcigyugngauten nallunaigutaitneq cali apcugngaten erinaigucirarqatneq qalaruskuvqi.

Cucukllillren ellpet qalarutnaluku wall qalarusn-gainaqi nallunairutesten, DA-m calivia qanescig-atuq qiall pillerqavneq . Ellpet cucuqllillerqavneq aperciratut. Cuciqliricquten qalarutllerkaitneq wall qalarutcingaitellren. Calistemeq DA-m calivianek aipangqersuquvet qanrusqiki, pinerlugcimalriit ikaiyuresti imna calituli paralegalameq aprumalria, ellpet pitekluten calilria, piavniaraten maligkavneq.

Mana nallunrisqiu-qalaruskuvni tauna alerkutneq calituli wall qanginaurta, ukuq asaql-luteq erriinaugyugngagten qanallerpeni.

✓ **Wani arcaqalriameq alerqutmeq navruillgulriani caliaqekiitni, piyunarqucingqertuten akurtullerqar-peneq uitavianeq cali qayaraurcutiin numbaneq, caliviim taum qaniciqellriim itercimallerkanek qalikameq maniarqameq cuqclistemun. Cali piyunarqucingertuten apqaurumallerqavneq taum qalikam igartineq itercimallerqameq egalriameq.** Tauna qanercetarumalria nallqumaqan arcaqalriameq alerqutmek navriurniluqu, cuqclista apellcigyugngauq umeq "itercimallerqaneq kalikameq". Mana kaliqak maniciquk nallunairutneq cuqclistemun taumeq qanercetarumalriim tungineq, alerqun navgullra, cali qaill matum ellpet yucin agtullra. Tauna piteqlluqu, tauna igartiin qaliquam nallunaigciqaten unang-naluni umeq "pinerlugcimalriim ayuqucian kaliqak".

Mana itercimallengquirun kaliqak qanrutkaarqaun-rilngucikuq. Kiingan district attorney-iq, cuqclista, qanercetarumalriim ikaiyugti cali qanercetarum-alriim-llu naksugngaqt tamallqun qaliquak. Ellpet naksugngan ilii qalikak itengqallerqiurpailrata apeskuvni ikaiyugten imumeq pinerlugcimalrianeq calituli lisngapialriim aciani calituli DA-m calivianeq

para-legalan. Makut uungut: (a)nanelicaumalria kaliqak imangertuq alerquun navrumallek (b) qanercetarumalriim qanrutii, (c)ellpet kanllerpeneq qaliquak nanelicaumalriameq imangertuq, cali (d)pisqutai itengallerkameq qalikam igartiin.

✓ **Tuani itengqallerqiurutmi piunarqucingkertuten niicimallerkavneq, apellciquvet.** Niicimayugngauten itengqallerqiurutmi waten:

1. Egagyugngan cuqclista, cali/wall;
2. Maanuatni qallarcugngauten itengqallerqiugatni, cali/wall;
3. Pinerlugcimalriim ayuqucian egaucimalria itengqallerqiugutmi mana apellciumalruk an.

Egagyugngaten wall qalaguteqlluqi arcaqalriit nallunaigutet makut elaklluqi:

1. Qaillun um alerqutem navgillran agtulruaten wall elaten(umyuavqun, temevqun wall aqimeq cagmallren) cali qaill matum yucin agtullra.
2. Umyuavni qaillun tuana piskumallerpeneq pinerlugcimasten piskesu(itengqasqelluku, qalagutesqelluqu umyuavneq calitulineq, avatevnnun ellpet wall elaten mallgumaskev-qenaqi, akit cimigluqi atullten insurance-avet aqiliksaitellri, allat-llu atullten).
3. Allat nallunaigutet cuqclistemun piavluqi qanercetagumalriim tungineq, wall matum auluqumalriim caliam.

Egaqvuni cuqclista, waten ayagniqiu:

Re: State v. (Qanercetagumalriim atra)
Case No. (numba waqen tegu-luku ellpet qalikavneq)

"Your Honor. (waten qirciqllugu cuqclista)...Winga pinerlugcimalriagunga matumi caliami," toill qanrulluku cuqclista piyullerpeneq. Tuyuqniaran taumun illalquamalriit tangvagtaitnek-llu calistinun(apkit paralegal-aq). Tuam tuyukciqa igan cuqclistemun. Qanercetagumalriim-llu ikaiyugtiin-llu unaqci-kak ayuqi igavneq taumun cuqclistemun cali aipagni qanercetagumalriamun enaqevkagcika.

Qalagucuquvet itengarqiiqata, qan-gusqiu para-legal-an DA-im caliviani sasagqiugniaraten pillerqavneq.

✓ **Piyunagqucingkertuten una nallunailerkavnek Violent Crimes Compensation Board-aq (cale-gyagaluteng navgillret alerkutneq calistiit) cali unangellerkan imigissutmek ayukucircutmeq.**

Una Violent Crimes Compensation Board-aq (VCCB) unguk: Uum napagcimarliim caliviim ikaiyularai pinerlugcimalret cagmarillret akiineq atullret naulluvigimun atulret, wall tamallret akit caliksaitellrem, cali qalagucagtullren umyuaneg calituli. Tukullruqan pinerlugcimalleq qingungi aqineq unangyugn-gaut umeq VCCB-meq aturqaneq tumagcillrat wall kingungi qaill pikairutellget tuqullrem auulqallri taqellruluteng. VCCB-iq cimigiuyitug tegliumallegneq wall navgullegneq aklluneq, cali aqiligngaunani aqikangellruriani allaneq (iinrivigneq insurance wall apkiitneq workman's compensation(una aqineq piavcituq calinginunrani cagmagillegmun). Tuatnayuqvet imigikina umeq apkitneq "Restitution Request Form" cali utrulluqu DA-em calivianun um eluani malruq nitiliq una qaliquaq unagerarluku. Wanigpaq tamallqan aqitutacia nallunakqan maniqiu wanirpak nallungillken aqitutacia cali qanrulluqi umiqu piavcinqiluku tamallqan akia qaqullu manicqniluku cipnega egnerquigluku-llu maniqatallren. Piingitevkenaq mana atuqiu. Matumi kaliqami imirisuun catailqan qayagaukiu paralegal-an DA-em caliviani ikaiyugniaraten.


